- 1. This approval relates to Briton 121CE closers which are overhead mounted door closing devices with adjustable latch action.
- 2. This certification is designed to demonstrate compliance of the product or system specifically with Approved Document B (England and Wales), Section 2 of the Technical Standards (Scotland), Technical Booklet E (N. Ireland). If compliance is required to other regulatory or guidance documents there may be additional considerations or conflict to be taken into account.
- 3. This approval relates to their use with the following door assemblies:-

Latched and unlatched, intumescent sealed door assemblies consisting of timber faced and edged leaves with timber, cellulosic or mineral cores in timber frames having a fire resistance up to 120 minutes (Code ITT).

- 4. The closers are approved on the basis of:
  - i) Initial type testing to EN1154 and EN 1634-1
  - ii) An appraisal against TS34
  - iii) Certification of quality management system to ISO 9001: 2008.
  - iv) Inspection and surveillance of factory production control
  - v) On-going audit testing in accordance with TS34 requirements
- 5. This approval is applicable only to the specified closers used in standard/regular arm, parallel arm or transom mounted configurations with door assemblies of proven fire resistance (as defined in BS EN 1634-1 or BS 476: Part 22: 1987) and having power ratings appropriate to the leaf sizes subject to a minimum size 3 (as specified in BS EN 1154).
- 6. The approval relates to on-going production. Product and/or its immediate packaging is identified with the manufacturer's name, the product name or number, the CERTIFIRE name or name and mark, together with the CERTIFIRE certificate number and application where appropriate.
